**SUBJECT:** Approval to award a construction contract for the Twelve Mile Road Irrigation project (from just west of Meadowbrook Road to just west of Novi Road) to American Sprinkler & Landscape, the lowest responsive bidder, in the amount of \$80,731.

### BACKGROUND INFORMATION:

This design/build project will establish an irrigation system for the median islands along a one mile stretch of 12 Mile Road from Novi Road to Meadowbrook Road. Irrigation of the median islands was not included in the scope of the Twelve Mile Gap project completed in 2003. While Twelve Mile Road is under the jurisdiction of the Road Commission for Oakland County (RCOC), Novi is responsible for providing landscape and irrigation within the median.

Five bids were received and opened on August 15, 2007 following a public bid solicitation period. The lowest responsive bidder is American Sprinkler & Landscape. American's bid is recommended as being in the best interest of the City as it is responsive (i.e., American has complied with all requirements of the bidding instructions) and it is the lowest price among responsive bids received. Three of the bidders were deemed non-responsive: Action Property Service and Michigan Automatic Sprinkler failed to acknowledge Addendums #2 and #3; and, Action, Michigan and Marc Dutton failed to provide unit prices on the bid form.

At this time, staff is recommending award of the Base Bid (irrigation system installation) and Alternate 1 (installation of sleeves under the existing median crossovers). Alternate 2 includes limited excavation and placement of topsoil, seed and mulch over the entire project area to establish turf (the medians currently have limited areas of viable turf growth). Staff will review existing Municipal Street Fund projects to determine if additional funds will be available to award Alternate 2 at a later date this construction season.


American has performed similar work in other communities installing landscape or irrigation systems in the median islands of Merriman Road, Mound Road and the Plymouth Road streetscape. They have also worked in Novi for the Sam's Club and Oakpointe Church.

Construction is scheduled to begin in September 2007 and will be completed by the end of November 2007.

- 1. "Electrical service conneciton is estimated cost only since actual DTE fees cannot be determined until meeting with DTE planner."
- "Alternate #2 includes round-up and rototill of existing vegetation"
- 3. "Road Commission permit LSUM includes monies for traffic control measures. An actual traffic control plan may have to be created and is not included. There "appears" to be only on electrical and water connection needed. Electrical connection includes boring under 12 Mile. All boring does not include any excavation or repair of roadways to located utilities that MUST be exposed under existing roadways. We believe properly placed bores will avoid such measures."
