SUBJECT: Approval of a resolution amending the number of students appointed to serve on the Novi Youth Council to 21, including 19 regular members and two alternates.

BACKGROUND INFORMATION:

On September 26, 2005, City Council adopted a Resolution creating the Novi Youth Council and appointed 19 high school students as founding members. Youth Council members are allowed five excused and two unexcused absences throughout the length of their two-year term.

This past year, attendance proved to be an issue for some members, resulting in the removal of one student from the Youth Council, leaving a vacancy.

This year, following a miscalculation regarding the number of returning members, 21 members were appointed to the Youth Council. It is recommended that the Youth Council membership be amended to include 19 regular members and two alternates, equaling 21. This revised membership will assist with consistent participation at Youth Council activities.
