SUBJECT: Approval of Resolution Amending Annual Assessment for Special Assessment District 81-01 and 81-02 West Lake Drive Street Lighting.

BACKGROUND INFORMATION:

The Special Assessment Districts 81-01 and 81-02 were established on September 28, 1981 and December 21, 1981, respectively, for the street lighting costs as billed by DTE for use and maintenance in the West Lake Drive areas.

The fund balance in this special assessment district as of June 30, 2011 was \$2,621, and estimated annual costs for 2011-12 are \$3,120. The current 2011 levy is \$2,810.

The recommendation is for the total annual roll for this district to be increased by \$489.98 to \$3,300 to cover increased usage and maintenance costs as billed by DTE.

The following preamble and Resolution were offered by Councilmember

WHEREAS, On September 28, 1981 and December 21, 1981, respectively, Street Lighting Special Assessment Districts 81-01 and 81-02 were established for the West Lake Drive areas; and

WHEREAS, said Districts established a total annual assessment of \$2,060.40 unless said amount was modified by Resolution of the Council; and

WHEREAS, the Special Assessment Districts were increased on June 19, 1989; on June 21, 1990; June 3, 1991 to reflect the cost of the lights as billed by DTE (formerly Detroit Edison); and

WHEREAS, said Districts were increased to a total annual assessment of \$2,810.02 on June 3, 1991; and

WHEREAS, annual usage and maintenance costs as billed by DTE have increased since the City Council's last modification of the annual assessment and an increase of \$489.98 annually is required to cover such current costs;

NOW THEREFORE, IT IS THEREFORE RESOLVED that Street Lighting Special Assessment Districts 81-01 and 81-02 be increased by the amount of \$489.98 to \$3,300.00, with said increase to be spread equally against the front footage in the districts.

BE IT FURTHER RESOLVED , that the Assessor is commanded to spread and the Treasurer to collect the various sums aforementioned.


