**BACKGROUND INFORMATION:**

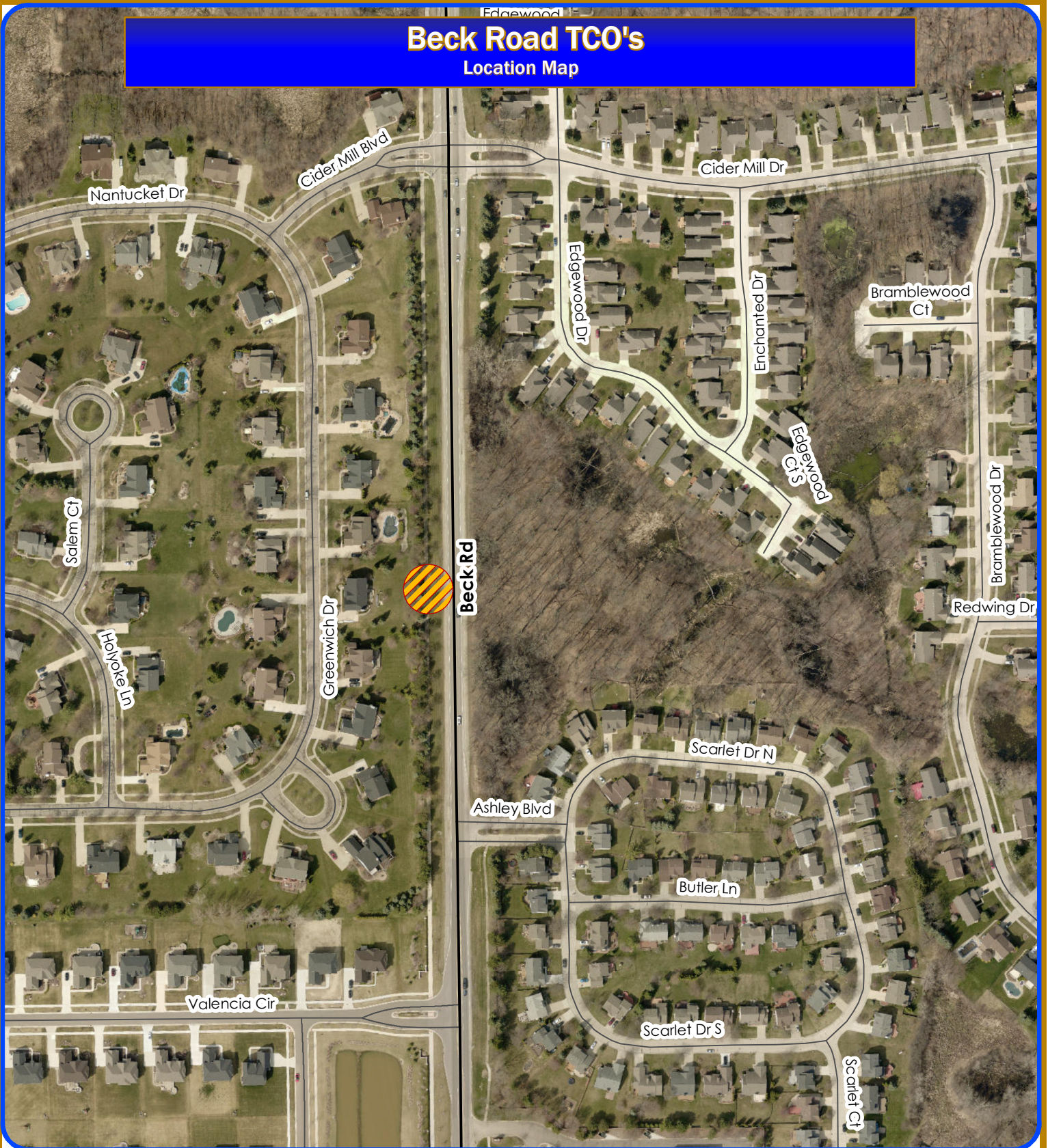
Beck Road has double yellow lines along the centerline at Ashley Boulevard to 10 Mile Road. DPW recommends installing a No Passing sign on the West side of Beck Road between 10 Mile Road and Cider Mill Boulevard and seeks City Council approval for a Traffic Control Order to allow enforcement of the No Passing signage.

Traffic control orders are required under the Uniform Traffic Code to enforce traffic control signs installed on public streets. Staff has prepared the following traffic control order for approval by City Council.

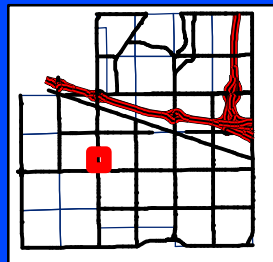
