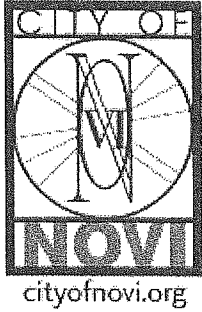
The Police Department, Fire Department and Building Department have reviewed the request and have no objections to the renewal of this license.

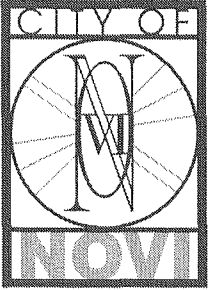

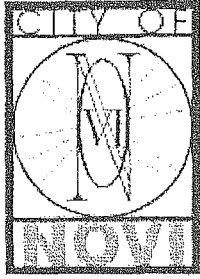
