Interim City Manager Cardenas explained that staff was asked by Council to reevaluate the situation. After discussion with RCOC it was determined there were no other options for re-routing traffic. This stretch is up for resurfacing in 2 years with support of RCOC. There should be little effect on the road.

Member Mutch questioned who had the authority for granting this. Mr. Schultz confirmed it could have been approved internally. Member Mutch asked administration to document the current condition of the road and then reevaluate the road conditions after the project in order to document any damage to the road.
