Total estimated project cost including grant is \$550,000 with the 30% City match of \$165,000.

BACKGROUND INFORMATION:

One of the goals of the Novi Parks, Recreation and Cultural Services Grant Committee is to identify potential land acquisition opportunities which may be good candidates for Michigan Natural Resource Trust Fund (MNRTF) acquisition grants. One potential parcel for acquisition is a 10 acre parcel located in the northeast portion of the city on 12 Mile Road east of Napier. Currently, the Novi Parks, Recreation & Cultural Services Department (PRCS) uses a park definitions and standards guideline for the acquisition and development of parks. These standards assist the PRCS Department in measuring progress toward equitable distribution of recreation resources, and in guiding policy decision on future resource allocation. Standards also serve as a basis for determining and prioritizing park construction projects. Neighborhood parks typically provide basic recreational opportunities close to home. Ideally all citizens have easy access to a neighborhood park within one-mile of their residence.

The PRCS Departments' goal for this piece of property is to develop a neighborhood park with potential features as open space, play structures, and picnic shelters. PRCS believes this park property is needed to support the new residential developments in the north west portion of the City. Currently, there are no other park facilities in close proximity for these residents. With the number of residential units being developed (Angelina Ridge 146 units, Berkshire Point 86 units, Knightsbridge Gate 349 units, as well as the Old Dutch Farms and Novi Meadows Mobile Home Park), a park feature is being recommended within walking distance to these new developments. Total estimated project cost including grant is \$550,000 with the 30% City match of \$165,000.

WHEREAS; the City Council has identified sources of funding to secure the 30 percent local match, which would total \$165,000.

NOW, THEREFORE, BE IT RESOLVED that the Novi City Council hereby resolves to take all actions necessary to submit a 2014 City of Novi Michigan Natural Resources Trust Fund (MNRTF) grant application in connection with the above-referenced Parcel 50-22-18-100-004 at 12 Mile Road east of Napier Road, subject to the following:

- 1. That the application identify a project cost of \$550,000.
- 2. That the City will provide a 30 percent local match in the amount of \$165,000.
