SUBJECT: Approval of traffic control orders 13-15 through 13-32 for traffic control signs within Bristol Corner West, Bristol Corners North and Bristol Corners South Subdivisions.

BACKGROUND INFORMATION:

Engineering staff have been working with the Bristol Corners Homeowners Association to replace the existing traffic signs within the Bristol Corners West Subdivision, Bristol Corners North Subdivision and Bristol Corners South Subdivision. Currently, the regulatory signs (stop, yield and speed limit signs) are on decorative posts along with the street name signs. The Association has requested that the city install the regulatory signs and has submitted a permit for the installation of new street name signs on decorative posts by the Association. (See separate motion sheet for the agreement in this regard elsewhere on the agenda).

A review of the subdivision revealed that all of the traffic control signs lack traffic control orders. Traffic control orders are required under the Uniform Traffic Code to enforce traffic control signs that have been installed. The table below summarizes the traffic control orders that were prepared by the traffic engineer for consideration by City Council.




