BACKGROUND INFORMATION:

This work involves the installation of a fire hydrant on the south side of Nine Mile, across from Montebello Estates, to provide additional fire suppression coverage in this area. To maintain the integrity of the Nine Mile Pavement, the new 8-inch water main will be installed via directional drilling methods under the road.

It is anticipated that this project will be completed by fall 2017.
