**BACKGROUND INFORMATION:**


As part of the 2012-2013 budget process, funds were allocated for the purchase of 65 new Sig Sauer P229 DAK duty pistols and holsters to replace our nearly decade old Glock 22 and 23 pistols. The transition is nearly completed with the Glock pistols traded in to off-set the costs of the new pistols and the used holsters collected for disposal.

The Novi Police Department would like to provide sixty-five (65) used duty holsters to the Grand Valley State University Police Academy for recruit training. The academy recently purchased Glock pistols and is in need of holsters to train future police officers.

The Novi Police Department recently transitioned all duty pistols from Glock 22 and 23 models to the Sig Sauer P229 DAK. The transition necessitated the purchase of new holsters and the used Glock holsters were collected for disposal.

I was recently contacted by Brian Luettker, lead firearms instructor at the Grand Valley State University Police Academy. Brian is a Bureau of Alcohol, Tobacco and Firearms (BATF) agent and former police officer for the City of Novi. Brian requested we supply the used Glock holsters to the GVSU Police Academy for use in the firearms training portion of the police academy. The holsters vary in condition and preliminary research indicates there does not appear to be a market for them. We currently have two GVSU Police Academy graduates at the Novi Police Department; Detective Wilson and Officer Hudechek.

I recommend we supply 60 right handed and 5 left handed used Glock duty holsters to the Grand Valley State University Police Academy for recruit training. Please contact me with any questions.
